## **New Business:**

## 5.c) Animal Control By-law/Agreement-first review

- It is agreed that the current Kennel owners and the Animal Control Officer should review the current by-law
- Sandy Briggs would like tags to sell perhaps a form filled out when collecting the fee, which would be brought to the office as proof of purchase and then the office will issue the actual tag and input into the computer system.
- Council would like a recommendation on what limit or maximum amount of dogs should be allowed safely in a home and in a kennel. – determine what the minimum amount of space per dog per size of dogs should be?
- Jamie Veraldi was afraid of setting limits and probable non-compliance.
- It was questioned on how Rescue Kennels are controlled.
- Copies of the current Animal control By-Law 2009-09 be sent to all Kennel Operators to get comments and propose changes etc. All responses to be returned to the Office- Kim Bester by September 16, 2015. A Special Meeting of Council is set for September 23, 2015 to review the proposed changes and to draft a new Animal Control by-law for the next Council Meeting. (October 6).

## 5.b) Municipal Alcohol Policy

The Policy was reviewed and a few changes were made. Enforcement is up to staff at the facility with the Alcohol event. Staff should take the Alcohol Safety Course that is offered by the Health Unit. Lesley Marshall will arrange for a training session for staff that will be responsible ie Mike Heasman, Dale Jardine, Bobbie-Lyn Roberts, etc.

Reviewed all of the proposed and highlighted changes. All changes were discussed and a final draft is now agreed on. We will post the Final Copy in the next Council Agenda (September 1, 2015) and will pass after it has had 30 days for Public Notice.
