BY-LAW NO. 2008-33

Being a By-law to impose fees or charges for services provided by the Corporation of the Municipality of Powassan

WHEREAS the Municipal Act, 2001 section 391 gives a municipality the authority to impose fees or charges for services or activities provided and for the use of its property;

AND WHEREAS the Corporation of the Municipality of Powassan has provided public notice in accordance with the Municipal Act, 2001 section 251;

AND WHEREAS the Corporation of the Municipality of Powassan deems it desirable to establish a by-law to impose fees or charges for services provided by the Municipality;

NOW THEREFORE THE CORPORATION OF THE MUNICIPALITY OF POWASSAN HEREBY ENACTS AS FOLLOWS:

- 1. That the fees and charges listed on the attached Schedule A to I of this by-law be adopted and hereby confirmed as being part of this by-law.
- 2. That this by-law shall come into effect January 1, 2008.
- 3. That By-law 2007-06 be repealed.

That this by-law be adopted as such in open Council this 16^{th} day of December 2008.

5% shall additionally be deducted for each field inspection that has been performed after the permit has been issued.

No refund shall be made:

- 1. Of an amount that is less than \$50.00
- 2. After one year from the date the permit is issued.
