

THE CORPORATION OF THE MUNICIPALITY OF POWASSAN

BY-LAW NO. 2009-03

BEING A BY-LAW TO SET RATE OF SPEED ON MUNICIPAL ROADS

WHEREAS Section 27 (1) of the Municipal Act, 2001 allows municipalities to pass a by-law in respect of a highway under its jurisdiction; and

WHEREAS the Council of the Corporation of the Municipality of Powassan deems it desirable to set the rate of speed on rural roads for the health and safety of its residents; and

WHEREAS Council of the Corporation of the Municipality of Powassan has hosted a public meeting on December 16, 2008 in order to solicit comment from ratepayers.

NOW THEREFORE the Council of the Corporation of the Municipality of Powassan hereby enacts as follows:

1. That Schedules A and B, attached hereto and forming part of this by-law be adopted.
2. That this by-law shall come into force upon the erection of the required signs.
3. That every person who contravenes any of the provisions of this by-law upon conviction is guilty of an offence punishable in accordance with the provisions of the Provincial Offences Act.

To Set Speed Limits – Urban Cluster Roads
Schedule “B”

That all maximum rate of speeds for inside the urban clusters be as follows:

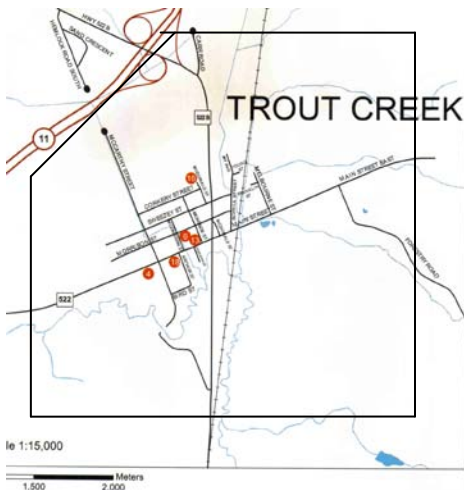
1. North Cluster Boundary Area, as defined below, be 40 km/h.

From Main Street North intersection at Valley View Drive West to
Memorial Park Drive East intersection at Valley View Drive East to
Main Street South intersection at Chiswick Line to
Clark Street (westerly most point) intersection of Hwy 11 N



2. South Cluster Boundary Area, as defined below be, 40 km/h.

From Carr Road intersection at Hwy 522 B to
Main Street East (easterly most point) to
McCarthy Street (southerly most point) intersection at Hwy 522B to
Chalet Road intersection at Hwy 522



All clusters exclude any and all Provincial Highways.
