BY-LAW NO. 2012-03

Being a by-law to renew the Agreement between the Corporation of the Municipality of Powassan and the City of North Bay to accept Household Hazardous Waste.

WHEREAS the Council of the Corporation of the Municipality of Powassan is desirous of renewing their agreement with the City of North Bay for continued use of the household hazardous waste program.

NOW THEREFORE BE IT RESOLVED THAT THE COUNCIL OF THE CORPORATION OF THE MUNICIPALITY OF POWASSAN ENACTS AS FOLLOWS:

- 1. That the Mayor and Clerk-Treasurer be authorized to execute the agreement renewal, attached as Appendix "A" and forming part of this by-law.
- 2. That this By-law be effective upon adoption.

RULES AND REGULATIONS

- 1. All vehicles entering the site must adhere to the posted speed limit of 5 kilometers per hour.
- 2. Residents will follow the directions/instructions given by the facility operators.
- 3. Residents will shut off their vehicles while unloading
- 4. Residents will provide their facility operators with the following information:
 - Municipality of origin
 - Type of waste
 - License plate number
- 5. Residents will immediately inform the operators if the delivery includes syringes/sharps and they will only be accepted if delivery is in a hard, rigid plastic container with a tape-sealed lid and labeled with the words "syringes and/or sharps".
- 6. Residents are not to mix different types of chemicals in the same container
- 7. No smoking is permitted within 5 meters of the facility's compound.

AGREEMENT BETWEEN THE CORPORATION OF THE MUNICIPALITY OF POWASSAN

AND

THE CORPORATION OF THE CITY OF NORTH BAY

TO ACCEPT HOUSEHOLD HAZARDOUS WASTE FROM RESIDENTS

OF THE MUNICIPALITY OF POWASSAN

The City of North Bay agrees to accept household hazardous waste from residents of the Municipality of Powassan subject to the following terms:

- 1. This agreement is effective January 17, 2012 to December 31, 2012; (the current operating hours of the facility are from April October).
- 2. The Municipality of Powassan will pay the City of North Bay a fee of \$2.00 per household.
- 3. The agreement is subject to renewal annually upon mutual consent of both parties.
- 4. All households delivering material to the facility must follow the rules and regulations of the facility (see attached).
- 5. The facility operators have the authority to refuse any material they are unsure of, deem to be unsafe or believe the material are not from a private household.
- 6. No commercial deliveries will be accepted.
- 7. No radioactive, biological, PCB's, explosives or ammunition will be accepted.
- 8. The City of North bay reserves the right to alter the operating hours of the site or change the method of operation if necessitated by existing or new government regulations or ensuring the site is in compliance with the facility's Certificate of Approval.
