



**THE CORPORATION OF THE MUNICIPALITY OF POWASSAN**

**BY-LAW NO. 2014-02**

---

Being a By-Law to Authorize the Clerk and Deputy Clerks to  
Provide Civil Marriage Services and to issue Marriage Licences

---

Whereas the Marriage Act authorizes the Clerk of a local municipality to solemnize marriages;

---

Whereas the Council of the Municipality of Powassan deems it expedient to provide a civil marriage service to the public;

Whereas pursuant of Section 11(2) of the Marriage Act, R.S.O. 1990, c.M.3, the Honourable Minister of Government Services may appoint the Clerk of a municipality as a person authorized to issue marriage licences for the municipality;

And Whereas the Council of the Municipality of Powassan deems it expedient for the public convenience that the Clerk and Deputy Clerks of the Municipality of Powassan be appointed in such capacity;

Now Therefore the Council of the Municipality of Powassan enacts as follows:


1. The Clerk and Deputy Clerks are hereby authorized to provide civil marriage services to the public.
2. The fee for said service during regular business hours shall be Three Hundred Dollars \$300.00 payable to the Municipality.
3. The fee for said service outside of regular business hours shall be Three Hundred Dollars (\$300)  
One Hundred and Fifty Dollars (\$150) payable to the Municipality and  
One Hundred Dollars and Fifty Dollars (\$150) payable to the Clerk or Deputy-Clerk for time spent.

4. The fee for attendance at the ceremony rehearsal outside of regular business hours (if required) shall be Fifty Dollars (\$50) payable to the Clerk or Deputy Clerk for time spent.


*Fees paid to the Municipality are subject to HST, and are in addition to the \$145.00 + hst non-refundable Marriage licence fee.*

5. The rate of mileage for ceremonies outside of the boundaries of the Municipality of Powassan shall be calculated at the current rate established by the Municipality.
6. The above fees do not include the fee for a marriage licence.
7. The Municipality of Powassan be and is hereby authorized to make application to the Honourable Minister of Government Services to have, the Clerk and Deputy Clerks of the Municipality of Powassan appointed as persons authorized to issue marriage licences for the Municipality of Powassan;
8. The fee for a marriage licence shall be One Hundred and Forty-five Dollars (\$145.00 + hst) payable to the Municipality;
9. The Mayor and the Clerk are hereby authorized and directed to do all such things and execute all such documents as may be necessary for the completion and implementation of the said appointment;
- 10.. This by-law shall come into force and effect upon the day of passing.
