**WHEREAS** the Corporation of the Municipality of Powassan is the owner of the Trout Creek Community Centre; and




1. That the Mayor and Clerk be authorized to execute the agreement, attached as Appendix "A" and forming part of this by-law.

**BETWEEN**

THE TROUT CREEK COMMUNITY CENTRE BOARD

Hereinafter referred to as the "TCCCB" OF THE FIRST PART

**AND**

THE MUNICIPALITY OF POWASSAN

Hereinafter referred to as the "MUNICIPALITY" OF THE

**SECOND PART**

This agreement is to replace the Agreement between the Municipality of Powassan and the Trout Creek Centre Board dated June 5<sup>th</sup>, 2001.

**WHEREAS** the Municipality of Powassan is the registered owner of the lands and premises including the building situated thereon, together with all assets, equipment, tools, furniture and fixtures situated at 181 Main Street West, in the former Town of Trout Creek, ON.

**WHEREAS** the operation and maintenance of the Trout Creek Community Centre is to be governed by the Trout Creek Community Center Board, this Committee is from this day forward to be considered a Committee of Council.

**THEREFORE** the Trout Creek Community Centre Board shall be composed of members of the community and one (1) member of the Council of the Municipality of Powassan.

**THEREFORE** the Municipality of Powassan shall be responsible for employees and shall be solely responsible for the payment of wages and benefits and for statutory withholdings.

**THEREFORE** the operation of the Trout Creek Community Center and all revenue and expenses associated with it shall be included within the annual Municipality of Powassan Budget, with standard municipal budgeting practices being applied.

**THEREFORE** the Municipality of Powassan shall be responsible for all general upkeep, maintenance, and repairs of the Trout Creek Community Centre, and through consultation with the Trout Creek Community Centre Board, from time to time, alterations, renovations, and repairs shall be made as deemed necessary.

**THEREFORE** the Municipality of Powassan supports the Trout Creek Community Centre Board and the valuable service it provides to our community. The Trout Creek Community Centre Board will be supported and encouraged by the Municipality to organize community events and activities.

**THEREFORE** the Municipality of Powassan agrees that it will continue to maintain and operate the Trout Creek Community Center unless reasons beyond budgetary constraints make it necessary to review the viability of doing so.
