THE CORPORATION OF THE

MUNICIPALITY OF POWASSAN

BEING A BY-LAW TO PROHIBIT OR REGULATE PARKING

WHEREAS Section 210 (123) and 314 (7) of the Municipal Act Chapter M.45 R.S.O. 1990 empowers municipalities to prohibit or regulate parking.

THEREFORE the Council of the Corporation of the Municipality of Powassan enacts as follows:

PART 1

DEFINITIONS

For the purpose of this by-law:-

- (a) <u>CORNER</u> means the point of intersection of curbs or edges of the portion of the highway used for vehicular traffic.
- (b) <u>CROSSWALK</u> means the point of intersection that is included within the connections of the lateral lines of the sidewalk on opposite sides of the highway measured from the curbs or, in the absence of curbs, from the edges of the roadway, or any portion of a roadway at an intersection or elsewhere distinctly indicated for pedestrian crossing by signs or by lines or other markings on the surface.
- (c) <u>HIGHWAY</u> means a common and public highway, street, avenue, parkway, driveway, square, bridge, viaduct or trestle, any part of which is intended for or used by the general public for the passage of vehicles and includes the area between the lateral property lines thereof.
- (d) <u>INTERSECTION</u> means the area embraced within the prolongation of connection of the lateral curb lines or, if none, then of the lateral boundary lines of two or more highways that join one another at an angle, whether or not one highway crosses the other.
- (e) <u>MUNICIPAL COUNCIL</u> means the Council of the Corporation of the Municipality of Powassan.
- (f) <u>PARK OR PARKING</u> when prohibited, means the standing of a vehicle, whether occupied or not, except when standing temporarily for the purpose of and while actually engaged in loading or unloading merchandise or passengers.
- (g) <u>PEDESTRIAN</u> means a person afoot and an invalid or child in a wheelchair or carriage.
- (h) <u>ROADWAY</u> means that part of the highway that is improved, designed or ordinarily used for vehicular traffic, but does not include the shoulder, and, where a highway includes two or more separate roadways, the term "roadway" refers to any one roadway separately and not to all of the roadways collectively.
- (i) <u>SIDEWALK</u> means that portion of a highway between the curb lines, of the lateral lines of a roadway and the adjacent property lines, intended for the use of the pedestrians.
- (j) <u>STAND OR STANDING</u> when prohibited, means the halting of a vehicle,

- whether occupied or not, except for the purpose of and while actually engaged in receiving or discharging passengers.
- (k) <u>STOP OR STOPPING</u> when prohibited, means the halting of a vehicle even momentarily, whether occupied or not, except when necessary to avoid conflict with other traffic or in compliance with the directions of a constable or other police officer or of a traffic control sign or signal.
- (l) <u>STREET</u> see Highway.
- (m) <u>TRAFFIC</u> includes pedestrians, ridden or herded animals, vehicles, streetcars and other conveyances either singly or together while using any street for the purposes of travel.
- (n) <u>TRAFFIC CONTROL DEVICE</u> means any sign, or roadway, curb or sidewalk marking, or other device erected or placed under the authority of the Municipal Council for the purpose of guiding or directing traffic.
- (o) <u>TRAFFIC SIGNAL</u> means any device manually, electrically or mechanically operated for the regulation of traffic.
- (p) <u>TRESTLE</u> means a braced framework of timbers, piles or steelwork for carrying a road or railroad over a depression.
- (q) <u>VEHICLE</u> includes a motor vehicle, trailer, traction engine, farm tractor, road building machine and any vehicle drawn propelled or driven by any kind of power, including muscular power, but does not include a motorized snow vehicle.
- (r) <u>WHEEL CHAIR</u> means a chair mounted on wheels driven by muscular or any other kind of power and used for the carriage of a person who has a physical defect or disability.

PART 11

PARKING

1. <u>METHOD OF PARKING</u>

(1) <u>Parallel</u>

No person shall park a vehicle on any street unless on the right hand side of the street, having regard for the direction in which the vehicle had been proceeding and unless the right front and right rear wheels or runners are parallel to and distant respectively not more than six inches from the edge of the roadway.

Angle

Where angle parking is permitted, no person shall park a vehicle except at an angle of forty-five degrees with the edge of the roadway.

2. <u>PARKING PROHIBITED</u>

(1) <u>In specified places</u>

No person shall park a vehicle in any of the following places:

On a sidewalk.

In front of a public or private driveway.

Within an intersection.

Within ten feet of a point on the curb or edge of the roadway adjacent to any fire hydrant.

On any bridge and/or any trestle or the approaches thereto.

In such a position as will prevent the convenient removal of any vehicle previously parked or left standing.

(2) <u>In specified places where signs are on display.</u>

When properly worded signs have been erected and are on display no person shall park a vehicle in any of the following places:

Beyond the posted signs depicting parking distance from intersections or six meters (6M) where intersections are not posted.

In front of the lot on which a fire hall is located on that side of the road.

Within six meters (M) of any point designated as a bus or coach stop.

3. PARKING RESTRICTIONS ON SPECIFIED STREETS

When signs have been erected and are on display no person shall park a vehicle on any street or part of street set out in Schedule "A", in the former Town of Powassan, Schedule "B", in the former Township of Himsworth South and Schedule "C" dictates parking in the former Town of Trout Creek.

4. PARKING PROHIBITED FOR SNOW REMOVEL

No person shall park, stop or stand any vehicle on any street between the hours of 1:00 a.m. and 8:00 a.m. during the months of November 1st to April 1st in each and every year, or when designated areas of snow removal are posted.

Any such vehicle will be towed away at the owner's expenses.

Neither will the municipality or any of its contractors be liable for any damage caused to such unlawfully parked vehicles by equipment engaged in the removal of snow.

PART 111

PENALTIES

Every person who contravenes any of the provisions of this by-law is guilty of an offence punishable in accordance with the provisions of the Provincial Offences Act.

PART IV

This by-law shall apply to the whole of the Corporation of the Municipality of Powassan.

SCHEDULE "C" TO BY-LAW NO.

SPECIFIED PARKING

- 1. Parallel parking only on both sides of Main Street between Arthur Street and Sophia Street.
- 2. South side of Main Street from the Canadian National Railway tracks to the Eastern boundaries of the former Town of Trout Creek.

AT THE TROUT CREEK COMMUNITY CENTRE

- 1. The area known as the entrance to the Community Centre fronting on Main Street
- 2. A 20 foot wide laneway along the westerly side of the Community Centre, extending from the Main Street property line to the southern end of the Community Centre.
