
NOW THEREFORE that the insurance program from Municipal Insurance Services Ltd. outlined on Appendix "A" attached be adopted and is forming part of this by-law.

RE: GENERAL INSURANCE RENEWAL

Dear Maureen:

We are pleased to enclose the renewal summary of coverage, limits and deductibles proposal for the June 1, 2013 to June 1, 2014 term.

Insurance property values have increased from \$22,335,804 to \$23,102,236 as a result of changes made during the last year and a 4% inflationary increase.

The following

1. Councillors' Accident **includes** Heart Attack and Spousal cover (for spouses when travelling with a member of council on municipal business).
2. **Out of Province Emergency Medical** is included as part of the Councillor's Accident program, (including Spouse).
3. OPCF-20 Loss of Use is included on three (3) light commercial vehicles.
4. Full replacement cost on all licensed vehicles except those which are in excess of twenty (20) years of age.

Therefore we are pleased to advise the revised renewal premium of \$105,960., plus PST. This is as a result of recent changes on the automobile schedule.


Please also find enclosed a copy of the Volunteer Fire Fighters' Accident enhancement sheet.

We continue to offer, as an option, accident coverage for all municipal volunteers on a blanket basis no matter the number, as long as they fall under the control of the municipality or its boards and committees. The limit provided for Accidental Death and Dismemberment is \$50,000 each at an annual premium of \$750.
